



- Shivalik Education Foundation, Sri Muktsar Sahib is a registered Society/Trust under the Societies Registration Act (XXI of 1860) and Punjab Amendment Act, 1957 with the registration no.5703 of 2015.
- 2. That the Shivalik Education foundation, Sri Muktsar Sahib is of Non-Proprietary Character.
- That the school is being run as a community service and not as business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The Saving, if any, after meeting the recurring and non-recurring expenditure and contributions to development, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
- 6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will Not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars contained issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc with respect to the school and staff of the school.
- 9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribe term.
- 10. That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

That State pattern classed IX to XII running prior to the affiliation to CBSE would be sponsored for the State Board Examination, State Pattern classes IX to XII will be closed in a phased manner, No admission will be taken in the State Board Pattern Class IX to XII after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE
